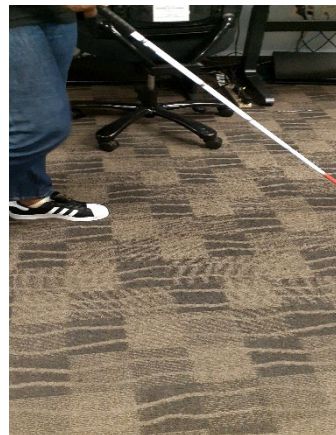

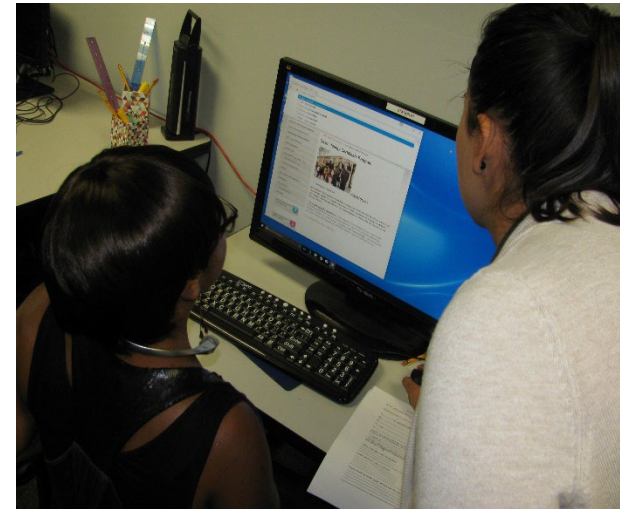

## Comprehensive Vocational Evaluation

Comprehensive Vocational Assessment provides a concise look at an individual's skills, aptitudes and interests to determine the next best career step. The purpose of Vocational Assessment and Evaluation is to assist you to obtain employment.

Vocational Evaluation is a comprehensive process that utilizes a range of work activities- both real and simulated as a tool to assess your capabilities. The Comprehensive Vocational Evaluation incorporates a range of information, including medical, psychological, social, vocational, cultural and economic data so we can be effective in helping you achieve your goals.

## Employment Services

ES includes, intake where an Individual Service Plan is created, resume writing, mock interviews, job aptitudes, individualized employment plans and job search assistance. Once a person is employed, there will be a year of general case management which includes supportive services. **This service is done in person only.**



## The Process- In Person Comprehensive Vocational Evaluation

Orientation

Individual vocational evaluation plan development

Initial assessments

Staff recommendations following assessments

Exit interview including written report submitted to referral agency

## Hybrid Services

Introduced in April 2020, these services are much like the in-person services except 60% is done virtually/ remotely and 40% is done in person when deemed necessary.

## Length of Evaluation

The length of your evaluation is determined by your counselor or referral agency and is based on your individual needs and the goals of the evaluation.
